These funds were used to fund construction of churches and schools and the operation, maintenance and supply of medicines to 2 diocesan hospitals - one in the Nuba Mountains (El Obeid diocese) and one in Yambio (diocese of Tombura-Yambio). The Sudan Relief Fund also advocated for the people of South Sudan by raising awareness of their situation through mailings, videos, and public events in the U.S.
